## **Committee Reports**

- Highway: The Highway Department continues to replace culvert pipes, and they are preparing for the upcoming winter months (preparing plows, ordering salt, trucks inspection, readying for sand haul). They've received a request for concrete platforms for two cemeteries, and the signs are being paid through an Alcoa grant.
- Airport: The Taxiway Phase I has been completed. The DOT has issued an RFP for Essential Air Service (EAS), the current EAS contract expiring in April 2019. Silver Airways and Cape Air have expressed interest in providing EAS, along with the current provider, Boutique Air. The Town has taken possession of the Terminal Hangar. Enplanements are up. The Car Show and Open House at the Airport was a success, and Councilman Miller indicated that he hopes the Town Council will consider hosting another event next year. He praised the Highway Department crew for their hard work at the event.
- Library: Electric power to the Library's sign has been connected. The Town is working with the Village to redo certain sidewalks at the Library.
- Arena: NYPA, as part of the Relicensing project, is working to replace the lights at the Arena with LEDs. NYPA will be responsible for all aspects of the project.
- Rescue Squad: There are a few new members of the MVEU, and they continue to work on recruitment of new members.
