Sue's Committee Reports May 20, 2020

1. Rescue Squad:

They did not meet this month, but bills have been submitted to Town totaling \$61,947.61. Members accumulated 2420 hours of donated service at value of \$58,322. Calls were reported for advanced life and basic life support with 41 non-transport with transported calls down by 31 compared to 2019. Calls to hospitals showed 10.8% to CP Hospital.

The Rescue Squad is looking to purchase a portable shower to follow NYS guidelines for Covid-19 cleanliness and safety; trying to be financially cautious but so far this month they have had to do 30 decontaminations of ambulances (2-3 times per night per vehicle). This is also the 60th anniversary of the Massena Rescue Squad and hopefully we will help them celebrate at some point this year.

2. Library:

The library board met on their scheduled date of May 12th by ZOOM.

Monthly business agenda items were completed as usual; with information on dealing with the coronavirus -19; phases for reopening; budget cuts through end of year affecting hours; extending loans of books to 6 weeks if not new books; free from fines on late books; receipt of names of people interested in running for the library board seats, and readying with publicity items to get out the vote - which will be by absentee ballots received no later than June 9th at 5pm, when the school district will process the results with poll inspectors that evening. Their next meeting is Thursday June 11th.

Additionally, Lib. Director Elaine notified us that North Country Lib. Systems listed items that need to be addressed prior to opening for curbside service, inclusive of a lib. Bd. meeting to make a resolution authorizing the library to open on a specified date (following the NCLS Reopening Guide).

3. The BDC met at same time as our special board meeting of May 6th. Jim will report.

Moved / replaced two driveway culvert pipes.

Massena Airport

Boutique Air numbers for April 2020 Enplaned 28, Deplaned 28, Total 56 Cancelled for weather 10, Cancelled other 16, Total cancelled flights 26. April 2020 landings for Boutique Air at the Massena Airport 81.

Received new Jet-A fuel truck from SkyMark. On Tuesday June 2, 2020 SkyMark Tech will be at the Massena Airport for training on the new Jet-A fuel truck along with St. Lawrence County Weights and Measures to calibrate meters on the fuel truck for dispensing fuel.

Received bids for the three Massena Airport projects.

Taxiway C Rehabilitation bid came in at \$1,446,744.00, FAA approved bid. Needs Town of Massena Board Approval.

Fence Improvement and Stabilization bid came in at \$1,316,374.00, FAA approved bid. Needs Town of Massena Board approval.

GA Rehabilitation bid came in at \$744,538.00. The supplemental discretionary funding for this project was \$727,000.00. There is additional cost that is associated with this project construction inspection cost, exceeds the allotted grant amount. If the project was to be completed in 2020 the Town of Massena local share would be around \$115,538.00. The Town of Massena can move this project to the 2021 ACIP and rebid and the Towns share would approximately \$22,000.00.

FAA approved the funding for 5-23 runway rehabilitation and lighting system design cost \$426,000.00. Needs Massena Town Board approval.

Received a letter from the NYS DEC that we have successfully closed out all inspection violations for Petroleum Bulk Storage.

Massena Library closed.

Having issue with security system and surveillance cameras.

Massena Town Hall Closed, Town hall personal only.

Was notified of water on the floor and damage sheet rock at the Massena Town Hall police station break room. Found steam line on outside wall leaking. Found that the streamline was imbedded in the concrete steps that are used to access the outside door into the alley way. Had to remove concreate steps, replaced steam line, replace concreate steps, replaced metal wall studs, sheet rock, mud, tape and paint. Estimated cost of repair \$650.00.

Received new services agreement from Siemens for the Massena Town Hall. Needs Massena Town Boards approval. The currant Service agreement expires on April 30, 2020.
